Amendment to Article III (adopted 4/4/09):

The purpose for which this corporation is organized is:

The purposes of this corporation shall be to provide mountain bike outings and environmental education for low-income youth from Hillsborough County communities; to provide outdoor outings (primarily bike rides), community service, and educational opportunities for "at risk" kids that do not have access to these types of activities within their communities or environments; and to combine lessons in personal responsibility, self-empowerment, achievement, and community service so that "at risk" kids are quipped with tools for building positive accomplishments and relationships within their communities and their lives.
