ARTICLE II PURPOSE

This corporation is organized exclusively for: **CHARITABLE, EDUCATIONAL, PROMOTING AMATEUR ATHLETICS, RELIGIOUS, SCIENTIFIC, THE ARTS & LITERARY** purposes.

within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall [promote literacy, enlist in community outreach activities and shelter assistance, engage in vocational skill training, job referrals, apprenticeships and employment placement for at risk youth, ex-convicts, and homeless individuals, court ordered case management, and follow along services, gymnastics , swimming, track and field, and intramural sports, music, dance, the performing and visual arts, computer science technology, physical science, health, wellness and nutrition, nature and ecology expeditions, drug prevention and intervention, home economics and cosmetology training, ministerial training and administrative services, and youth and family Biblical counseling.] All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE III LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;
2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or

referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and

3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

4. The corporation shall not lend any of its assets to any officer or director of this corporation [unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-Board members!!], or guarantee to any person the payment of a loan by an officer or director of this corporation.
