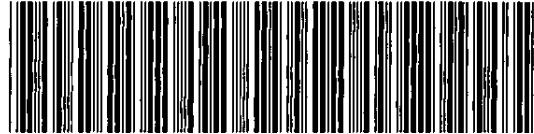

Statement of Purpose

##### Additional Provisions

1. Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on::(1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempt-

ting to influence legislation [except as otherwise provided by Section 501(h) of the Internal Revenue], and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
