

## FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF FLORIDA ASSOCIATION OF REALTORS® EDUCATION FOUNDATION, INC. Soundation, Inc., a. Florida

WHEREAS, the Florida Association of REALTORS® Education Foundation, Inc., a Florida not for profit corporation (the "Foundation"), was created pursuant to the Articles of Incorporation of Florida Association of REALTORS® Education Foundation, Inc. (the "Articles of Incorporation"), effective April 14, 2009; and

WHEREAS, said Foundation has been continuously in effect since April 14, 2009, and will continue to be in effect as amended pursuant to the terms of this instrument; and

WHEREAS, the Foundation has no shareholders or members and this First Amendment to Articles of Incorporation was approved and adopted on November 12, 2010, by a majority vote of the Board of Directors of the Foundation;

NOW, THEREFORE, pursuant to Chapter 617 of the Florida Statutes, the "Florida Not For Profit Corporation Act", and the right of amendment reserved in Article XII of the Articles of Incorporation, the Foundation hereby amends Section 3.1 of the Articles of Incorporation as follows [additions are indicated by <u>underlining</u>]:

3.1 Purposes. The Foundation is organized exclusively for charitable, religious, educational, and scientific purposes. More specifically, the Foundation will provide, fund, administer, and implement real estate related scholarships and educational grants (including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code")). The Foundation is required to carry on charitable, etc., activities within the meaning of section 170(c)(2) of the Code.

IN WITNESS WHEREOF, and In accordance with Section 617.01201(6)(a), Florida Statutes, the undersigned officer of the Foundation has executed this First Amendment to Articles of Incorporation this 2 day of November, 2010. Pursuant to Section 617.0123, Florida Statutes, the effective date for this First Amendment shall be the date of filing with the Florida Department of State as evidenced by the Department of State's date endorsement on the original document.
