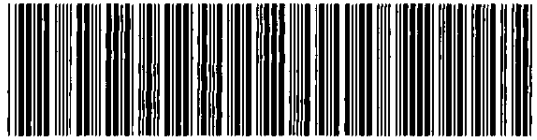

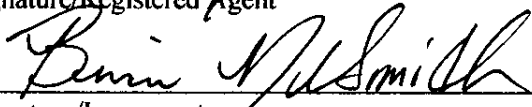

ARTICLE III- PURPOSE

1. FRS Foundation, Inc. has been organized in order to promote active, healthy lifestyles amongst individuals in the community, and to provide support to other non-profit organizations that promote such lifestyles through community health and fitness initiatives.
2. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
3. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
