

ARTICLES OF INCORPORATION PRECIOUS PAWS RESCUE A NOT FOR PROFIT CORPORATION FOUNDED MARCH 24, 2009

ARTICLE ONE NAME AND LOCATION

A. PRECIOUS PAWS RESCUE, Inc. c/o Mary Neron 13161 S. Betty Pt., Floral

ARTICLE TWO DURATION OF THE CORPORATION

The term of the corporation shall be perpetual, unless terminated by action of its members or by operation of law.

ARTICLE THREE PURPOSE

This corporation is a not for profit corporation organized under Chapter 617, Florida Statues. It is not organized for the private gain of any person. The primary purposes of this corporation are to reduce pet overpopulation and to relieve the suffering of animals by rescuing, fostering and rehoming unwanted or abandoned animals; to inform and educate the public regarding the basic pet care, the importance of spay / neuter practices to control pet overpopulation and to seek funding for these procedures as a part of all organizational activities.

All funds raised through adoption fees and donations will be used to provide direct and necessary care for all animals in the program including, but not limited to, veterinary care, rescuing / fostering, housing, and adoption expenses according to the provisions set forth in the Bylaws and Fostering and Adoption Policy and Procedures.

The corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers: but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE FOUR MEMBERS

The corporation shall be an all-volunteer operation with no paid employees. Membership will be open to all persons who successfully complete the application process and pay dues for an annual membership. Membership and voting rights will also be available to any individual, business or corporation conducting business with the Corporation. Any individual, corporation or business or their representative(s) will be ineligible to hold an elected position while engaged in a business relationship with the Corporation. They may serve in an advisory position. The rights and privileges of members are set forth in the Bylaws.
