

Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

of

JEREMIAH YOUTH CENTER INC.

Article I

The name of the Corporation shall be: Jeremiah Youth Center Inc.

Article II

The principal place of business and mailing address of this Corporation shall be:

Article III

Jeremiah Youth Center Inc. is a PUBLIC BENEFIT nonprofit corporation that is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including, for such purposes, the making of distributions to organizations that qualify as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code. Specifically, this nonprofit corporation is organized and operated to provide relief to poor, distressed, and underprivileged youth, by providing a unique and stimulating environment that allows them to reach their fullest potential, to provide youth with the invaluable opportunity to actively participate in activities that will help mold them into successful and thriving individuals of our future, to promote and encourage youth to participate in recreational and educational activities for the ultimate benefit of their physical and mental well being, and to promote the overall happiness and well being of the youth, by enabling them to overcome their hardships and fortify their weaknesses, and become strong, confident, and successful individuals of the future.

Article IV

The manner in which the directors are elected or appointed: During the annual meeting, the officers shall elect the directors of the Corporation.

Article XI

Purpose of Obtaining 501(c)(3) Tax-Exempt Status: No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.

Dissolution: Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
