ONE: The name of this principal corporation is Young Men of Promise Inc. and the address is 1143 Dunbrooke Street Winter Garden, FL 34787. The corporation is organized pursuant to the Florida Nonprofit Code.

TWO: This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: The Young Men of Promise (YMOP) Mentoring Project concentrates on leadership development, academic enhancement, social responsibility, community service, and school pride. The program encourages teenage boys to make positive life choices and helps them build their leadership skills. The Young Men of Promise (YMOP) Mentoring Project seeks to support one to one mentoring programs for youth at risk of educational failure, dropping out of school, or involvement in delinquent activities, including gangs and drug abuse.

THREE: The duration of this corporation shall be perpetual, stock and shall have other members.

(b) Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

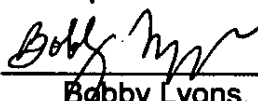

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
