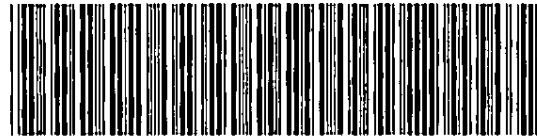

**AMENDMENT TO ARTICLE III - PURPOSE(S):**

Remove in its entirety "Equine Riding Club".

**ADD ARTICLE IX:**

The organization is organized exclusively for charitable purposes, including the making of activities to the public that qualifies as an exempt organization under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future tax code or amendments thereof. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas in Brevard County, Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized or operated exclusively for such purposes.
