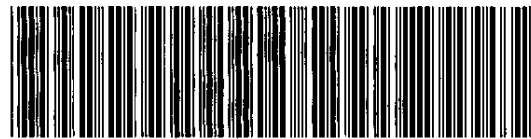

Pursuant to the provisions of section 617.1006, Florida Statutes, Wes Weekley Ministries, Inc. adopts the following amendment to its Articles of Incorporation:

**A. Article III – Statement of Purpose**

The word “benevolent” is removed from the first sentence of paragraph 3.1. The amended Article III reads as follows:

**STATEMENT OF PURPOSE**


**3.1 Statement of Purpose.** WES WEEKLEY MINISTRIES, INC. is a not for profit corporation organized for charitable, religious, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law)(the “Code”), including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code. It is to engage in religious, missionary, and charitable works and in the conduct, establishment, growth of churches, hospitals, clinics, dispensaries, schools, Bible institutes, orphanages and Christian community works in the United State of America and abroad.

**B. Effective Date of Amendment**

The date of this amendment adoption is of 3 June 2010.

**C. Adoption of Amendment**

There are no members or members entitled to vote on the amendment. The amendment was adopted by the board of directors.
