

The undersigned, for the purposes of forming a not for profit corporation under the Florida Not For Profit Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE ONE NAME

The name of the not for profit corporation is NEW BEGINNINGS MINISTRY OF SW FL, INC, whose principle business address is 2448 Jamaica St., Port Charlotte, FL 33980 and mailing address is P.O. Box 510143, Punta Gorda, FL 33951-0143.

ARTICLE TWO DURATION

The term of existence of the not for profit corporation is perpetual and the date and time of the commencement of the not for profit corporation's existence shall be the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE THREE PURPOSE

The purposes for which the organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, specifically to conduct regular church worship services and ministry to the community.

or by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
