ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not For Profit)

ARTICLE 1

The name of the Corporation should be **IGLESIA CRISTIANA PENTECOSTES MOVIMIENTO MISIONERO MUNDIAL PANAMA CITY INC.**

ARTICLE 2

The principal office of the Corporation is **318 School Ave., Panama City, FL 32401.**

ARTICLE 3

The corporation will promote the basic principles of the Christian faith through the teaching of the Bible and assist his members in achieving a better understanding of their spiritual, moral and cultural obligations according to Christian's principles.

ARTICLE 4

Our directors and officers are appointed by the Elder Board after spiritual, doctrinal and educational skills are met.

ARTICLE 7

ARTICLE 6

This corporation is organized for the purpose of conducting a ministry and any legal activity conducted by non-profit corporations under the laws of the State of Alabama of America. More specifically, but without reservation or restriction, this corporation shall be organized and operated exclusively for religious and charitable purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, or any superseding section. This corporation shall, among other things, organize Faith-Based Initiatives and conduct religious and charitable activities deemed fit by the organizers.

ARTICLE 6

Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the non-profit purposes of the corporation and the corporation shall not carry on any activity not permitted to be carried on by an organization exempt from any Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or under the corresponding section of any future United States Revenue law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any

applicable Federal Tax Code, or shall be distributed to Federal Government for public purpose. Any such assets not so disposed of shall then be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is located. And the disposal shall be carried out exclusively for such purpose, or to such organizations as the said court shall determine, which are organized and operated exclusively for such purposes.


