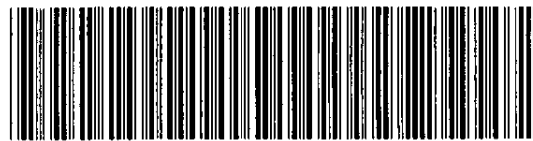

DESIRING TO FORM A NON-PROFIT CORPORATION UNDER THE NON-PROFIT CORPORATION
LAW OF

FLORIDA STATUTES, AND DO HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION

ARTICLE I




