CERTIFICATE OF FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF MARBELLA LAKES CONDOMINIUM ASSOCIATION, INC. (a Florida corporation not for profit)

We, Tambra Wolfe and N. Maria Menendez, as President and Secretary, respectively, of MARBELLA LAKES CONDOMINIUM ASSOCIATION, INC., a Florida corporation not for profit ("Association"), do hereby certify under the seal of the Association as follows:

- A. The Association was originally incorporated on April 16, 2009, Charter Number N09000003787, under Chapter 617 of the laws of the State of Florida;
- B. The Association wishes to amend the Articles in accordance with the requirements of Article XIII of the Articles which provide that prior to the recording of the Declaration amongst the Public Records, the Articles may be amended by an instrument in writing signed by the President and Secretary and filed in the Office of the Secretary of State of the State of Florida.
 - C. The Declaration has not been recorded in the Public Records.
 - D. There are no members of the Association entitled to vote on the amendment to the Articles.
 - E. The amendment was adopted by the Board of Directors of the Association on November 14, 2009.

NOW, THEREFORE, the Articles are hereby amended as follows (additions appear as underlined text and deletions appear as striked-through text):

- 1. Paragraph D.1.g. of Article IX is amended to read as follows:
 - g. Seven (7) years after recordation of the Declaration, or in the case of an association which may ultimately operate more than one condominium, seven (7) years after recordation of the declaration for the first condominium it operates, or in the case of an association operating a phase condominium created pursuant to s. 718.403, seven (7) years after recordation of the declaration creating the initial phase, whichever occurs first. The developer is entitled to elect at least one member of the Board of the Condominium Association as long as the developer holds for sale in the ordinary course of business at least 5 percent (5%), in condominiums with fewer than 500 units, and 2 percent (2%), in condominiums with more than 500 units, of the units in a condominium operated by the association. Following the time the developer relinquishes control of the Association, the developer may exercise the right to vote any developer-owned units in the same manner as any other unit owner except for purposes of reacquiring control of the association or selecting a majority of the members of the board of administration.
