The undersigned incorporator, for the purpose of informing a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is: **KINGDOM LIFE INTERNATIONAL MINISTRIES OF SOUTH ,FL INC,**

**ARTICLE II**

**ARTICLE III**

**PURPOSE**

The purpose of Kingdom life international ministries,(meeting the needs of the people by the word of God) is organized are exclusively for religious, charitable , and educational purpose within the meaning of section 501(c ) (3) of the Internal Revenue Code, including, for such purpose, the make of distributions to organizations that qualify as exempt organizations under section 501(c ) (3 )of the Internal Revenue Code, or the corresponding section of any future United States Internal Revenue Law.

1. Kingdom Life International Ministries, (KLIM)is organized are exclusively as a church promoting the advancement goal and idea of Christianity. In addition, KLIM, purpose is:
  - a. To provide spiritual training to our partners/members and missionaries
  - b. To promote strong moral character
  - c. To provide a place and atmosphere to worship God.

2. KLIM, is also organized for the purpose of providing social services as part of the church ministry.
  - a. To provide comprehensive counseling and spiritual guidance, and also to low-income at risk youth, age six to adulthood.
  - b. To provide shelter ,food, financial support and other needs to low income and at risk youth ages six-adulthood.
  - c. To assist and guide low income, and at risk youth in their spiritual educational, emotional, and personal development and growth.
  - d. To provide other assistance, opportunities, programs, activities and events necessary and relative to the overall principle for maintaining a spirit filled life and the restoring of families.
  - e. To provide comprehensive counseling and spiritual guidance to broken and at men , women, ages eighteen and beyond
  - f. Allow to receive loans, or grants to function programs also for the betterment of the church
  - g. To perform and /or provide any other services allowed under Florida Law.

#### **ARTICLE IV**

##### **DISSOLUTIONS:**

Upon the winding up and dissolution of this corporation, NO part of the net earning of this corporation shall inure to the benefit of, or be distributable to any of its members, trustees, officers, or other private persons, except that the corporation shall be authority to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of the exempt purposes. The remaining assets shall be distributed for one or more exempt purpose within the meaning of section 501 (c ) (3) of Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in including the publishing or distribution of statements any political campaign on behalf of in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by corporation exempt from federal income tax under section 501 (c ) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code , or by a corporation, contributions to which are deductible under section 170(c ) (2) of the Internal revenue Code or the corresponding section of any future federal tax code.

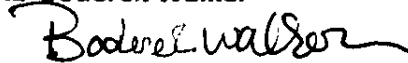

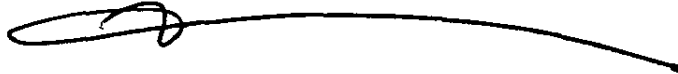
