

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BIG DOG MINISTRIES, INC.



Article III and VIII of the articles of incorporation of Big Dog Ministries, Inc. was amended by the corporation's board of directors on 10 - 32 - 09, 2009. The corporation is filing these articles of amendment to articles of incorporation pursuant to F.S. 607.0602.

- 1. The name of the corporation is Big Dog Ministries, Inc..
- 2. Article III and VIII of the articles of incorporation of Big Dog Ministries, Inc. was amended as follows:

Article III

The specific purpose for which this corporation is organized is:

To work with and counsel underprivileged youth to be productive adults in our community, thereby lessening the burden of government and reducing neighborhood tensions. We also work with underprivileged families providing them with hot meals and ministry, all within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Article VIII

Upon dissolution of the organization, the assets shall be distributed to one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code to one or more exempt organizations as determined by the IRS. The decision shall be made by the Board of Directors.
