#### ARTICLES OF INCORPORATION

OF

## TRAFALGAR COMMERCIAL PROPERTY OWNER'S ASSOCIATION, INC., a Florida corporation not-for-profit

The undersigned, the subscriber to these Articles of Incorporation, being a natural person competent to contract, does hereby form this Corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation shall be Trafalgar Commercial Property Owner's Association, Inc.

#### ARTICLE II - NATURE OF BUSINESS

The nature of the business of this corporation shall be to own and manage the common areas of the Trafalgar Commercial as shown on the Plat thereof in the Public Records of Osceola County, Florida.

#### ARTICLE III - POWERS

This corporation shall have all powers provided by law, and all powers set forth in that certain Declaration of Covenants, Conditions, and Restrictions for Trafalgar Commercial subdivision, as recorded in the Public Records, Osceola County, Florida (hereafter "the Declarations"), and everything necessary or suitable or proper for the accomplishment of any one of its purposes or the attainment of any one or more of the objectives enumerated above.

#### ARTICLE IV - MEMBERS OF THE CORPORATION

Every owner of a lot in the Trafalgar Commercial Subdivision shall be a member of this corporation, and there shall be no members of this corporation who are not lot owners of the Trafalgar Commercial Subdivision. The profits of the corporation shall not inure to the benefit of any member or other person, and no member or other person shall have any ownership interest in the corporation or any asset thereof.

#### ARTICLE V- VOTING OF MEMBERS

The Association shall have two (2) classes of voting membership:

- (a). Class A members shall be all Lot Owners with the exception of the Declarant and shall be entitled to one vote or fraction or multiples thereof, which shall be proportional to the square footage of the Lot(s) owned by that Lot Owner, in relation to the total square footage of all Lots in the Plat. When more than one person holds an interest in any Lot, all such persons shall be deemed to be one member. The vote for such Lot shall be exercised as they among themselves determine, but in no event shall more than one person cast votes with respect to any one Lot. In any action requiring a vote, the majority of the votes cast shall be decisive. Lot Owners may assign written proxies so long as written notice of an intention to do so shall have been served upon the Association within three (3)days prior to any meeting.
- (b). The Class B member shall be the Declarant and shall be entitled to three (3) votes for each Lot owned by the Declarant. The Class B membership shall cease and be converted to Class A membership on the happening of any of the following events, whichever occurs earliest: when the Declarant is the Owner of no more than one (1) Lot; or ten (10) years from the date of recording of this Declaration, whichever shall first occur.

#### <u>ARTICLE VI - TERM OF EXISTENCE</u>

This corporation is to exist perpetually. In the event of any distribution of assets upon dissolution or final liquidation, no assets shall be distributed to the

members, but shall be distributed to a domestic or foreign corporation not-forprofit.

#### <u>ARTICLE VII – TERMINATION OF MEMBERSHIP IN CORPORATION</u>

Membership in this corporation shall be terminated upon sale or transfer of ownership of any lot(s) owned by a member, and any successor in interest shall be bound by the terms of these Articles and the Declaration.

### ARTICLE VIII - EXERCISE OF CORPORATE POWERS, DUTIES, MANAGEMENT

The corporation shall be managed by its directors, who shall be three or more persons elected by the members under such terms and conditions set forth in the Declarations or By-Laws of the corporation or as otherwise provided by law.
