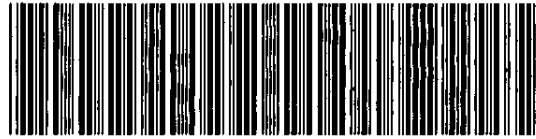

purpose for which the corporation is organized is to increase the number of marrow donors on Be The Match Registry with

a special emphasis on the recruitment of minority donors.

disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is

then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are

organized and operated exclusively for such purposes.

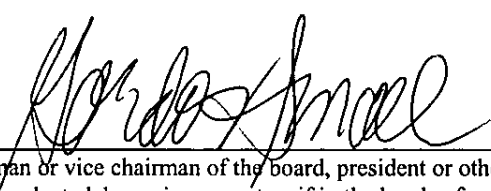
