

The programs Will consist of but shall not be limited to: Affordable Communities, Job Training, Job Placement, land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage pregnancy, substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly care and other programs to aid those in need.

THREE: The duration of the corporation shall be perpetual, no stock and shall have no members.


