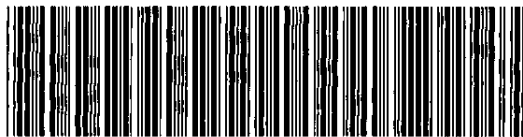

ARTICLE I: NAME

The name of the Corporation shall be **MINISTERIO ABRIENDO SURCOS** **ALLAHASSEE, FLORIDA**

ARTICLE V: RESTRICTIONS ON ACTIVITIES

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE VI: MANNER OF ELECTION

The manner in which the directors are elected or appointed: shall be appointed as provided for in the bylaws. The Board of Directors shall consist of THREE (3) persons. The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however, there shall never be less than three directors.
