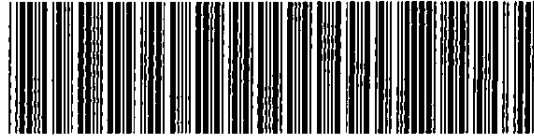

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- (a) to encourage the establishment of recreation and competitive softball and baseball programs, teams and leagues.
- (b) to aid in the development of the physical and mental well being of the participants/members of the program.
- (c) to enhance the self esteem and to provide leadership roles for the players.
- (d) to instill firmly in the players of the program the ideals of (i) good sportsmanship (ii) loyalty, honesty, courage (iii) respect for the game (iv) respect for ones parents & authority (v) and honesty so they may be well adjusted, more skilled and happier people and will grow and continue to develop into good, decent, trustworthy adults.
- (e) to create supervised softball & baseball activities for players, such as softball and baseball teams, leagues, and programs, softball & baseball related schools, clinics, camps, private instruction, for the purposes of teaching softball & baseball related skills, conditioning, & knowledge to the players and encouraging participation in such activities.
- (f) to raise money through registration fees, activity fees, sponsors fees, coaching fees, or any other activities which are necessary to support the program, to organize said softball/baseball activities, to purchase softball/baseball equipment and other related softball baseball items, whenever it is deemed necessary by the program, and in general to achieve the purposes of the softball/baseball program.
- (g) to acquire by gift, lease, purchase, or otherwise, personal, mixed, or real property for uses and purposed of the program, and to sell, lease, and dispose of the same at the discretion of the programs directors; and
- (h) to make and perform contracts, and to perform any other acts, and to engage in any other activity or business which is now or may hereafter be permitted under the law of United States and of the State of Florida, and to do and perform any and all things necessary or incident to the performing and carrying out the objectives of the softball/baseball program and the powers articulated hereinabove specifically delegated or implied.
