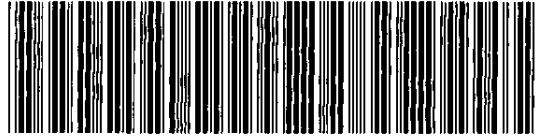

**The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law In Compliance with Chapter 617.0202, F.S., (Not for Profit)**

**ARTICLE I. NAME**

**ARTICLE II. PRINCIPLE OFFICE**

The place in this state where the principal office of the Corporation is to be located is the City Trinity, in Pasco County, Florida, the street address and mailing address, is: 1610 Winding Willow Drive, Trinity, Florida 34655

**ARTICLE III. PURPOSE**

Said corporation is organized exclusively for charitable and religious purpose including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


