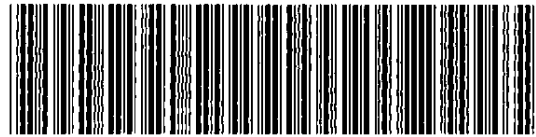

**ARTICLES OF INCORPORATION**  
**In Compliance with Chapter 617, F.S., (Not for Profit)**

**Article I    Name of Corporation**

The name of the corporation shall be: West Point Parents Club of Central Florida, Inc.

**Article II    Principal Office**

The principal office of the corporation is:

903 Kensington Street  
Lakeland, Florida 33803

**Article III    Purpose**

The purpose for which the corporation is organized is as follows:

**First:**

The purpose of the corporation is to provide assistance, encouragement, and support to the United States Military Academy cadet sons and daughters of members and to each other in matters pertaining to cadets. In addition, the corporation will provide information and encouragement to parents of prospective cadets as well as assistance to the Academy Liaison Officers assigned to the Central Florida area.

**Second:**

West Point Parents Club of Central Florida, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

**Third:**

No part of the net earnings of West Point Parents Club of Central Florida, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that West Point Parents Club of Central Florida, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Second hereof.

No substantial part of the activities of West Point Parents Club of Central Florida, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

### **Article III Purpose (continued)**

#### **Third: (continued)**

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **Fourth:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### **Article IV Manner of Election**

The manner in which officers and directors are elected shall be as follows:

An annual meeting will be held to elect officers and directors of the corporation. The date, time and location shall be noticed to all members in advance. Nominations will be requested from the members and presented to the membership at the annual meeting at which time an election will be held. The members present at such meeting shall elect the officers and directors for the ensuing year.

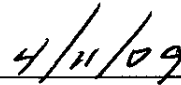

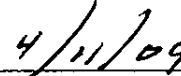
