**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

#### **ARTICLE V - Limitation of corporate powers**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

IGLESIA CRISTIANA MANANTIAL DE FE, INC., is to have the power to do any and all things necessary or expedient for carrying out the purposes of this corporation, and in general to possess all rights, privileges and immunities, and to enjoy all the benefits granted to corporations of similar characters under the laws of the State of Florida. These powers shall include, but not be limited to:

1. Erect, purchase, enter into a lease agreement, and maintain and upgrade, business offices, and such other structures deemed necessary to carry out the overall purposes of this corporation.
2. Collect, solicit, and accept funds, gifts, and other subscriptions necessary to purchase, lease and maintain all facilities used for the stated purposes of this corporation as a nonprofit organization.
3. Conduct Bible studies, perform all Christian religious services as well as any other activities and programs of Christian nature admissible by law.
4. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.




