

I, the undersigned, being the President of FUNIES FOUNDATION, INC., a Florida non-profit corporation, whose Articles of Incorporation were filed on April 27, 2009, under the name FUNIES FOUNDATION, INC., a Florida non-profit corporation, do now submit this Second Amendment to the original Articles of Incorporation in the following particulars:

AMENDMENT ADDING ARTICLES IX AND X

The Articles of Incorporation are hereby amended by adding the following Articles IX and X, to read as follows:

ARTICLE IX: Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law)."

ARTICLE X: Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code."
