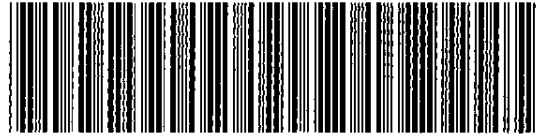

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I - Name

The name of the corporation shall be: JESUS Rocks International, Inc.

Article II – Principal Office

The principal place of business of this corporation shall be: 37 Coral Way Key West, FL 33040

The mailing address of this corporation shall be: 37 Coral Way Key West, FL 33040

Article III - Purpose

The purpose for which the corporation is organized is: Preaching the Good News of JESUS CHRIST through Church ministries; Schools; purchasing the property in Boca Chica; the former submarine docks, as The LORD enables; equipping the saints to become effective leaders of the Gospel; mercy ministries; and international outreach. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


