ARTICLES OF INCORPORATION

for

THE RIGHT MINISTRY, INCORPORATED

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, associate ourselves as incorporators, and hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I: NAME

The name of this not for profit corporation is The Right Ministry, Incorporated.

ARTICLE II: PRINCIPAL OFFICE

The principal office of the corporation is located at 5133 Tallow Wood Ct., Orlando, FL 32808.

ARTICLE III: PURPOSE

The primary purpose for which this Corporation is formed is to provide for public worship of God, to promote the teachings and practices of sound Christian living according to the doctrines and ordinances of the Bible, perform Biblical marriage counseling, Biblical youth/ parental counseling, and work with at risk youth through the creation and implementation of various programs to get and keep them on the right track. The foregoing statement shall not be deemed to preclude a statement of general purpose of the Corporation and shall not in any way limit or restrict the power of the Corporation to engage in other lawful business enterprises and activities that are consistent with the mission of the organization.

This Corporation is established exclusively for recognized purposes under Section 501(c)(3) of the Internal Revenue Code, such as charitable, religious, educational, or scientific causes. In conducting its affairs so as to maintain its status as a tax exempt organization, the Corporation shall not carry on any activities prohibited by a tax exempt organization under Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE IV: MANNER OF ELECTION

The Board of Directors of the Corporation shall consist of such persons, in such numbers, for such terms of office, and shall operate in such manner as set forth in the by-laws of the Corporation. The Board of Directors of the Corporation shall be elected in accordance with the by-laws of the Corporation.
