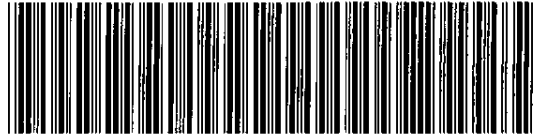

ARTICLES OF INCORPORATION OF
UNTIL HE COMES, INC.

The undersigned incorporator, a natural person 18 years of age or older, in order to form a corporate entity under Florida Statutes, Chapter 617, Corporations Not For Profit, adopts the following Articles of Incorporation:

Article I. Name

The name of this corporation shall be "Until He Comes, Inc."

Article II. Principal Office

The corporation's principal street address is 2715 NW 39th Avenue, Gainesville, FL 32605.

Article III. Duration

Until He Comes, Inc., shall exist perpetually.

Article IV. Purpose

Until He Comes, Inc., is organized exclusively for religious, charitable, and educational purposes and shall at all times be operated for such purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

Specifically the express purposes of Until He Comes, Inc., are as follows: to assist the homeless and needy of the city of Gainesville and Alachua County by providing religious guidance, friendship, and serving as a liaison to the network of Gainesville ministries and organizations that provide specialized charitable assistance. Until He Comes, Inc., consists of students from the University of Florida and the larger Gainesville community.

Article V. Exemption Requirements

At all times the following shall operate as conditions restricting the operations and activities of Until He Comes, Inc.,:

1. Until He Comes, Inc., shall not have or issue shares of stock. The corporation is not organized, nor shall it be operated, for the primary purpose of generating pecuniary gain or profit. No part of the property, assets, profits, and net earnings of Until He Comes, Inc., shall inure to the benefit of, or be distributable to its members, officers, or other private persons,

except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV.

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

3. Notwithstanding any other provisions of these Articles, Until He Comes, Inc., shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article VI. Directors

The method of election or appointment to the Board of Directors shall be established in the corporation's Bylaws. The Board of Directors, as established by the Bylaws, shall never be fewer than three. No Director shall have any right, title, or interest in or to any property of Until He Comes, Inc.

Article VII. Membership

The Bylaws shall provide the qualifications for and responsibilities of membership, and the manner of admission to membership in Until He Comes, Inc.

Article VIII. Personal Liability

No member, officer, or Director of this corporation shall be personally liable for the debts or obligations of Until He Comes, Inc., of any nature whatsoever, nor shall any of the property of the members, officers, or Directors be subject to the payment of the debts or obligations of Until He Comes, Inc.

Article IX. Dissolution of Assets

Upon the dissolution of Until He Comes, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
