Articles of Incorporation

IGLESIA BUENA ESPERANZA, Inc.

ARTICLE I

The name of this corporation shall be Iglesia Buena Esperanza Inc.

ARTICLE II

The principle office and mailing address shall be located at 745 High Pines Drive, Naples, Florida 34103, in Collier County, Florida.

ARTICLE III

The purposes of this corporation shall be as follows:

To teach about, train leaders to serve and promote the spiritual needs of the Hispanic community through the worship of the Triune God.

To expand spiritual teachings to all Hispanic communities around the world.

ARTICLE IV

The manner in which the directors are elected or appointed shall be by the recommendation and vote of the Board of Directors, as more fully described in the By-laws, if any.

ARTICLE V

The Board of Directors shall consist of not fewer than three (3) persons, the exact number to be determined from time to time in accordance with the By-laws, said By-laws to be adopted by the Directors within six (6) months of approval of these Articles. The initial Directors are as follows:

Daniel E. Jimenez, 3235 La Costa Cir., Apt. 106, Naples, FL;
Paul Munro, 511 22nd Street SE, Naples, FL 34117; and
Julie Yamin, 745 High Pines Drive, Naples, FL 34103.

The initial Officer is as follows:

ARTICLE VI

The registered agent for this corporation shall be Julie Yamin, and the registered office shall be 745 High Pines Drive, Naples, FL 34103.

ARTICLE VII

The initial incorporator shall be Richard P. Webster, 1650 Ixora Drive, Naples, FL 34102.

ARTICLE VIII

This corporation shall have all the powers and authority granted to it under Chapter 617, *Florida Statutes*.

ARTICLE IX

In the event of dissolution, the residual assets of the corporation shall be transferred to one or more organizations which themselves are exempt as organizations under § 501(c)3 of the Internal Revenue Code or corresponding section(s) of any prior or future Internal Revenue Code. Further, it is the desire of the corporation that such assets be distributed to those organizations which have substantially similar purposes as those of Iglesia Buena Esperanza, Inc.

ARTICLE X

Iglesia Buena Esperanza, Inc. is organized exclusively for charitable, educational and/or scientific purposes under 501(c)3.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the

publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, Iglesia Buena Esperanza, Inc. shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under § 501c3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under § 170c2 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Having been named as registered agent to accept service of process for the above state corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
