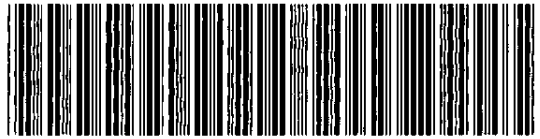

**Articles of Incorporation of
North Port Neighborhood Watch, Inc.**

A Florida Nonprofit Corporation

Article 1 – Name. The name of the Corporation is North Port Neighborhood Watch, Inc.

Article 2 – Address. The principal place of business is 4970 City Hall Boulevard
North Port, FL.

The mailing address is P.O. Box 7613 North Port, FL 34290

Article 3 – Purpose. The purpose of the Corporation is as follows:

1. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is an organization of concerned citizens, voluntarily working in the community to help prevent crime. To provide citizens with training and experience in observation skills and report procedures, with emphasis on safety.
2. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
3. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under Internal Revenue Code and no part of the net earnings of the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4 – Manner of Election. The Corporation shall have Voting Members, who shall elect (and may be removed) officers by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. Elections will be held every two years. The Corporation Officers shall be individually elected by a majority vote of the Voting Members. The officers of the Corporation shall consist of a President, Vice President, Secretary and Treasurer. Other officers may be provided for in the Bylaws. Further details regarding the election, qualification, removal or resignation of directors are included in the By-laws of the corporation.

Article 5 – Initial Officers. The initial officers shall have 4 members whose names and address are:

Walter Sternberg – 4098 Kessler Terr, North Port, Florida
Mina Sundeen - 4089 Fairway Dr, North Port, Florida
Michael Shingledecker – 3251 Duar Terr, North Port, Florida

The number of officers may be raised or lowered by amendment of the bylaws but shall in no case be less than three.




