Section 1.02. Purpose. S.E.E.D. Fund for Kids is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501 (c) 3 of the code, including, for such purposes, the making of distributions to organizations that qualify as exempt ones under Section 501 (c) 3 of the Internal Revenue code or corresponding section of any future federal tax code. The Corporation is organized for the charitable and educational purposes for children that are financially, emotionally and or physically disabled.

Section 2.06. Powers. No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the

carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not be conducted for any purpose not permitted to be conducted a) by an organization exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue code, or corresponding section of any future federal tax code, or b) by an organization, contributions to which are deductible under Section 170 (c) 2 of the Internal Revenue code.

DISSOLUTION CLAUSE

Upon dissolution of the S.E.E. D. Fund, Inc., assets shall be distributed for one or more exempt purposes within the meeting of Section 501 (c) 3 of the Internal Revenue code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed

of by the Court of Common Pleas of the county (Santa Rosa, Florida) which houses the principal office of S.E.E.D. Fund, Inc. or any location in which the organization is located at the time of dissolution. This deposition by the Court of Common Pleas shall be exclusively for such purposes or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
