Article One: Organizational Structure

The Abu Bakr Islamic Center shall be governed by the following bodies:

- 1. Majlis Al-Shura (Board of Directors)
- 2. Board of Trustees
- 3. Executive Committee
- 4. Committees (as needed)

Article Two: Board of Trustees

The Board of Trustees shall act as custodians of the organization's assets and ensure that the Majlis Al-Shura and Executive Committee act in the best interests of the center. The Board of Trustees shall oversee the organization's dissolution process, requiring a unanimous decision of both the Board of Trustees and Majlis al Shura.

Article Three: Membership

Membership in the Abu Bakr Islamic Center shall be open to individuals who reside in the Tampa Bay area, adhere to Islamic principles, and agree to abide by the center's constitution.

Article Four: Dissolution

- In the event of dissolution, all assets shall be transferred to an Islamic organization in North Dissolution must be decided by a two-thirds (2/3) majority of both the Board of Trustees and the Majlis Al-Shura.

Articles of Incorporation of Abu Bakr Islamic Center (ABIC)

Governing Law and Purpose

The Abu Bakr Islamic Center (ABIC) shall be governed by applicable state and federal laws for nonprofit organizations, including but not limited to the Florida Non-Profit Corporation Act and the Internal Revenue Code Section 501(c)(3). All activities and operations of the center shall follow these laws to maintain its nonprofit status and ensure legal protection.

The purpose of the Abu Bakr Islamic Center is to serve the Muslim community by providing religious, educational, and charitable services. These activities shall be carried out in accordance with the teachings of the Quran, Sunnah, and the consensus of Islamic schools of thought. The center aims to foster spiritual growth, community engagement, and promote understanding of Islam within the broader community.

The organization shall be guided by the principles of Islam as derived from the Quran, the Sunnah of Prophet Muhammad (peace be upon him), and the consensus of Islamic scholars (Ijma). The organization shall also consider the diverse interpretations within Islamic jurisprudence (Fiqh) and ensure that the activities, teachings, and decisions of the center remain in accordance with these principles.
