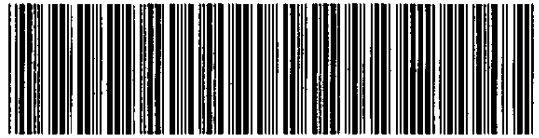

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

The name of the corporation shall be Contractors for Christ, Inc.

ARTICLE II: PRINCIPAL OFFICE

The place in this state where the principal office of the non profit Corporation is to be located is 121 Queens Court, Sanford, FL 32771.

ARTICLE III: PURPOSE

Said corporation is organized exclusively for charitable, religious, educational purposes, including, for such purposes, to reach unchurched Christians by organizing them as a family of believers to serve Christ in their communities. This non profit corporation will provide opportunities by calling Local Missionaries to serve in the community by establishing outposts such as small family groups, cells of weekly Bible studies, various youth activities to educate children and young adults in the ways of Christ and providing avenues for men and women to serve Christ in their communities and the world though the gifts they have been given and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICE IV: MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be determined and stated in the Bylaws.

ARTICLE V: INITIAL DIRECTORS/OFFICERS AND TRUSTEES

The names and addresses of the persons who are the initial trustees of the corporation are as follows:

President- JAMES G. TIMMONS of 121 Queens Court, Sanford, FL 32771.

Vice President-SHERRY TIMMONS of 121 Queens Court, Sanford, FL 32771.

Treasurer- JOHN LYNCH of 1872 Marley Place, Longwood, FL 32750-3786.

Secretary- JENNIFER KING of 121 Queens Court, Sanford, FL 32771.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in article third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to a candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VI: DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

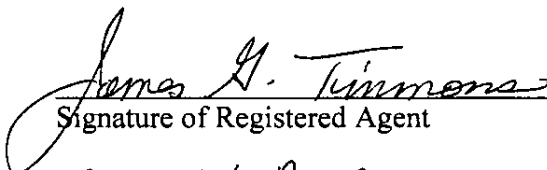
