ARTICLES OF INCORPORATION

OF

SPECIAL NEEDS TAX CREDIT ALLIANCE, INC. a Florida Not For Profit Corporation

The undersigned, a natural person of the age of eighteen or over, desiring to form a corporation pursuant to the Florida Not For Profit Corporation Act, does hereby certify:

FIRST: The name of the corporation is Special Needs Tax Credit Alliance, Inc. (the "Corporation").

SECOND: The street address of the initial principal office of the Corporation is 4673 Brady Boulevard, Delray Beach, FL 33445.

THIRD: The Corporation is organized exclusively for promoting the creation of congressional legislation that will provide a federal tax credit for legal and other professional fees associated with establishing legal guardianship or an irrevocable third party supplemental needs trust for a child or adult with disabilities to lessen the burden on families with a disabled family member of providing for the future needs and well-being of such members.

FOURTH: The number of directors constituting the initial Board of Directors of the Corporation is three (3), and the names and addresses of the persons who are to serve initially are:
