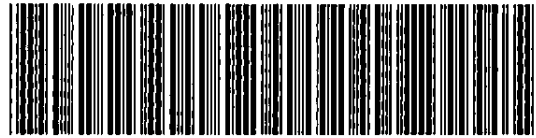

The undersigned, for the purpose of forming a corporation in compliance with and pursuant to Chapter 617, Fla. Stat., (the "Florida Not For Profit Corporation Act"), hereby certifies:

Article I: Name
