## AMENDED ARTICLES OF INCORPORATION

Pursuant to the provisions of Section § 617.1007, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following stated amended articles of incorporation.

1. <u>Name</u>. The name of the corporation shall be Royal Palm Coast Realtor® Association Housing Foundation, Inc. pursuant to the adopted name change dated April 17, 2017, Docs #N09000004488 and #500297363085.

2. <u>Principal Office</u>. The principal place of business and the mailing address of this corporation shall be: 2840 Winkler Ave., Fort Myers, FL 33916.

3. <u>Purposes</u>. This corporation is organized, and shall be administered and operated, exclusively to receive, administer and expend funds for the following charitable and educational purposes of the Royal Palm Coast Realtor® Association Housing Foundation, Inc, a Florida not-for-profit corporation that is exempt from federal income tax under §501(c)(3) of the Internal Revenue Code of 1986:

(a) To make grants and otherwise facilitate the ability of attainable / affordable service workers, public safety workers, medical support workers, and others who desire to live and work within the Association's geographical boundaries, to purchase homes in Southwest Florida;

(b) To provide educational programs for real estate agents and brokers and the general public;

(c) To provide financial assistance to individuals in Southwest Florida who have been victims of hurricanes and other natural disasters;

(d) To assist, by grants and otherwise, other charitable and educational organizations in the conduct of similar activities; and

(e) To engage in any and all lawful activities to accomplish the foregoing purposes except as restricted herein.

In order to accomplish the foregoing charitable and educational purposes, and for no other purpose or purposes, the corporation shall have all of the powers granted to nonstock corporations by §617.0302 of the Florida Not-For-Profit Corporation Act; provided, however, that the corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of the corporation.

4. <u>Manner of Election of Directors</u>. The directors shall be elected or appointed in the manner prescribed in the bylaws.

5. <u>Incorporator</u>. The incorporator shall be Al Giacalone, whose address is 2840 Winkler Ave., Fort Myers, FL 33916.

6. <u>Registered Agent</u>. The registered agent shall be Chene' M. Thompson, Esq. whose address is 1833 Hendry Street, Fort Myers, FL 33901. . .

Other Provisions. (a) No part of the net income of the corporation shall inure to the benefit of or 7. be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the purposes and objects set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of or against any candidate for public office.

Notwithstanding any other provision set forth in these Articles of Incorporation, at any time during (b) which it is deemed a private foundation, the corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986; the corporation shall distribute its income for each taxable year at such time and in such manner as to not become subject to the tax on undistributed income imposed by Section 4942 if the Internal Revenue Code of 1986; the corporation shall not own any excess building holdings that would subject it to tax under Section 4943 of the Internal Revenue Code of 1986; the corporation shall not make any investment in such manner as to subject it to the tax imposed by Section 4944 of the Internal Revenue Code of 1986; and the corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986. Any reference in those Articles to any section of the Internal Revenue Code of 1986 shall be deemed to incorporate by reference the corresponding provisions of any subsequent federal tax laws.

Notwithstanding any other provision of these Articles, the corporation shall not conduct or carry (c) on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, or by an organization contributions to which are to be deductible under Section 170(c)(2) of such Code.

Upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation (d) shall be distributed exclusively for the corporation's charitable and educational purposes, or to organizations which are then exempt from federal tax under Section 501(c)(3) of the Internal Revenue Code of 1986, and to which contributions are then deductible under Section 170(c)(2) of such Code.

(e) These Articles of Incorporation may be amended or restated in the manner provided by the applicable provisions of the Florida Not-For-Profit Corporation Act, provided that no amendment or reinstatement, or articles of merger, consolidation, or dissolution, shall be filed with the Secretary of State or become effective unless and until it has been approved by the Board of Directors of the Royal Palm Coast Realtor® Association, Inc.
