Article 3: The Veterans Fund for Children exists for the sole purpose of collecting and distributing procured goods for the direct relief of hungry and impoverished children of the Americas, including for such purposes, the making of distributions that qualify as exempt organizations under section 501 c 3 of the Internal Revenue Code, or corresponding setion of any future federal tax code.

Article 8: Upon dissolution of The Veterans Fund for Children, any assets shall be distributed for one or more exempt purposes within the meaning of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a a state or local government, for a public purpose.
