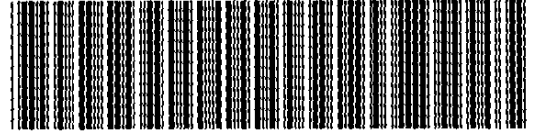

ARTICLE I.

NAME

The name of the corporation shall be OneWay Student Ministries, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The principal address of the corporation is 17200 NW 87 Avenue, Miami, Florida 33015

ARTICLE III.

PURPOSE

1. The principal aims and objectives of OneWay Student Ministries, Inc., are to provide programs and services meant to enhance the emotional, social, mental, and spiritual development of the youth. The foundation of our philosophy is the belief that every young person has a purpose, and the ability to achieve personal success. We believe that the promise of their success is found in a relationship and fellowship with God. This will be achieved through the organization and provision of a continuing youth program. The number, qualifications, terms of office, manner of election, time and place of meeting, and power or duties of Directors shall be prescribed by the Bylaws of the Corporation, except where the method of election of any particular officers or officer is specifically provided for herein.
