Gospel of Jesus Christ throughout the world.

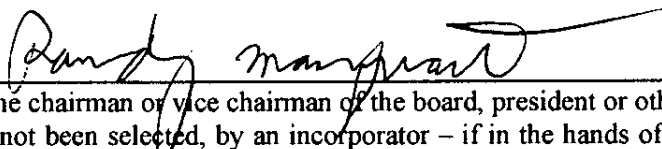
