ARTICLES OF INCORPORATION
OF
SENT BY ANGELS, INC.
(In Compliance with Chapter 617, F.S., Not for Profit)

The undersigned Incorporator, for the purpose of forming a corporation in compliance with Chapter 617, Florida Statute, (Not for Profit), hereby adopts the following Articles of Incorporation.

ARTICLE I
Name

The name of the corporation shall be: SENT BY ANGELS, INC. ("the Corporation")

ARTICLE II
Principal Office/Mailing Office

The principal place of business and mailing address of the Corporation shall be 4931 NW 172nd Terrace, Carol City, Florida 33055.

ARTICLE III
Purpose

The purpose for which this Corporation is organized is exclusively charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law and to provide assistance to cover the financial burden of purchasing headstones for children to mark their final resting place.

ARTICLE IV
Manner of Election

The bylaws shall specify the manner of nomination and election of directors.

ARTICLE V
Initial Directors/Officers

ARTICLE VIII
Dissolution

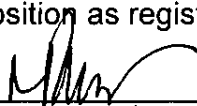
Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed, shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX
Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors.
