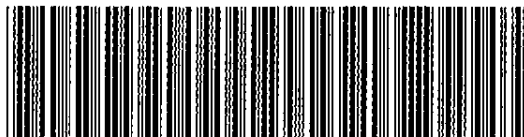

We, the undersigned have this 17<sup>th</sup> day of April, 2009, voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

**Article 1. Name**

The name of this corporation is Legacy105, Incorporated, referred to hereafter as the "Corporation."

**Article 2. The Principal Place of Business and Mailing Address**

The initial street address of the principal office of this corporation is 416 tarpon Street, Kissimmee, Florida 34744. The Board of Directors may from time to time move the principal office to any other address in Florida.

**Article 3. Purpose**

The purposes for which this Corporation is organized are to establish a college access program dedicated to providing comprehensive college preparation assistance to low-income and underrepresented students and those who are the first generation in their family to attend college.

The Corporation is organized and operated exclusively for educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code.

**Article 4. Manner of Election**

The directors constituting the first board of directors shall either be named in the articles of incorporation or elected by the incorporator and shall hold office until the first annual meeting of members or for such other period as may be specified in the articles of incorporation or the bylaws. Thereafter, directors shall be elected or appointed in the manner and for the terms provided in the articles of incorporation or by the bylaws. In the absence of a provision fixing the term of office, the term of office of a director shall be for one year.

**Article VI. Initial Directors and Officers**

The number of initial directors of this corporation shall be seven and the names and addresses of the initial directors are as follows:

The period of duration of this Corporation is perpetual.

**Article 7. Members**

The Corporation shall have no members.

**Article 8. Dissolution**

The property of this corporation is irrevocably dedicated to educational purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by

Section 501 (h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the internal revenue code.
