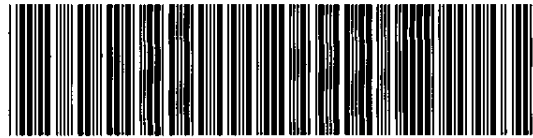

**ARTICLES OF INCORPORATION
OF THE
PARTIDO LIBERAL CUBANO, INC**

(A Not for Profit Corporation, in compliance with Chapter 617, F. S.)

The undersigned, acting as incorporators of a Corporation pursuant to *Chapter 617, Florida Statutes*, adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation shall be:

PARTIDO LIBERAL CUBANO, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal business and mailing address of the Corporation is:

ARTICLE III: PURPOSE

The purpose for which the Corporation is organized is for promote among our members, among the exiled Cubans and its descendants in United States of America and the whole World, and among Cubans in Cuba, the virtues of liberal democratic thinking and the need to reestablish Democracy in Cuba. To promote and educate about the merits and benefits of the liberal ideology from its historical roots and developments to its modern approaches.

To promote and educate about the merits and benefits of a social and cultural order based in full individual liberty and personal empowerment, Human Rights, Rule of Law, Representative Democracy, nonintrusive small central government and noncoercive social solidarity.

To promote and educate about the merits and benefits of stopping and disband the totalitarian communist regime in Cuba, and in restore a new democratic Republic for the Cuban Nation, rooted in its own real traditions, able to bring prosperity and happiness to its citizens and to exist peacefully on a par with all democratic Nations in the World.

That include unite all efforts, skills and resources available to and within our members and its communities in order to, by all legal means and as soon as possible, bring to an end the totalitarian communist regime and restore liberty, democracy and

prosperity in Cuba. And after that, fully participate in the remake and empowerment of the future new republic.

That includes promoting, by all legal means, the spreading of these ideals among all Cuban and its descendants living in USA and the whole World. And equally includes promoting over the whole World the Knowledge of the real dimension of the Cuban tragedy under a totalitarian communist regime.

And, by all legal means and over the whole World, promoting the urgent need of free the Cuban people by radically dismantling the totalitarian communist regime and remaking the Cuban Nation, social, cultural and politically under, the principles of a modern liberal democracy: people's sovereignty expressed by a representative democracy and the rule of law; full expression and exercise of the individual freedom and Human Rights. And all of these, rooted in the traditions and laws, of the previous liberal democratic republic that the Cuban Nation enjoyed until the year 1959. That include mainly but not only the principles of the Cuban 1940's Constitution.

ARTICLE IV: MANNER OF DIRECTORS ELECTION

The manner in which Directors are elected or appointed is as follows: As stated by the By-Laws of the ***PARTIDO LIBERAL CUBANO, INC.***

ARTICLE VI: POWERS

The corporate powers of this Corporation are as provide in ***Section 617.0302, Florida Statutes***, unless limited are as follows: only as limited by the laws of the ***PARTIDO LIBERAL CUBANO, INC.***

ARTICLE VII: TERMS OF EXISTENCE

This Corporation shall have perpetual existence.

In the event of a voluntary dissolution of the Corporation, the Directors shall after paying all liabilities of the Corporation distribute all remaining assets to one or more qualified nonprofit organizations. If the Directors cannot agree upon a qualified organization the Directors shall transfer all the above assets of the Corporation to a court of competent jurisdiction for disposition.
