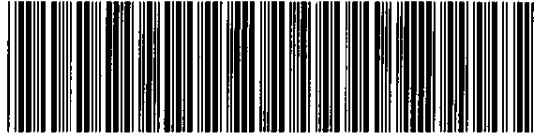

ARTICLES OF INCORPORATION

OF

*Mission 12:30, Inc.*

(A CORPORATION NOT FOR PROFIT)

The undersigned Incorporator, being a person competent to contract, subscribes to these Articles of Incorporation to form a NOT FOR PROFIT CORPORATION under the laws of the state of Florida.

*ARTICLE I - Name*

The name of the corporation is Mission 12:30, Inc.

*ARTICLE II - Principal Office*

The street address of the initial principal office of the corporation is 309 W Oakland Avenue, Oakland, FL 34760, and the mailing address of the corporation is P.O. Box 404, Oakland, FL 34760.

*ARTICLE III - Initial Registered Office and Agent*

The street address of the corporation's initial registered office is 309 W Oakland Avenue, Oakland, FL 34760, and the name of the initial registered agent of the corporation at such address is Paul Zakhary.

*ARTICLE IV - Incorporator*

The name and street address of the incorporator of the corporation is:

#### *ARTICLE V - Term of Existence*

The corporation shall commence its corporate existence on the date these Articles of Incorporation are filed with the Department of State, and shall have perpetual existence thereafter unless dissolved according to law.

#### *ARTICLE VI - Members*

The corporation may have one or more classes of non-voting members, and the qualifications for membership shall be regulated by the bylaws, including the manner of admission and dismissal of members.

#### *ARTICLE VII - Directors*

The corporation shall initially have one (1) directors. Except for the initial directors named herein, the directors shall be elected and removed by the majority vote of the remaining directors or director. The qualification, number and terms of directors, and the time, place and conduct of meetings of directors shall be regulated by the bylaws of the corporation, subject to the restrictions and limitations imposed by law, or in the event the bylaws are silent on any issue, as established by the laws of the State of Florida. Following are the names and street addresses of the initial directors who shall hold office until they either resign or are removed as set forth herein:

#### *ARTICLE VIII - Officers*

The directors of the corporation shall appoint such officers as they deem appropriate to manage the day to day activities of the corporation, including, but not limited to, a president and secretary, for such terms and with such authority as set forth in the bylaws of the corporation. The same individual may simultaneously hold more than one office.

#### *ARTICLE IX - General Purpose*

The corporation is formed exclusively for charitable, religious, educational, scientific and/or literary purposes which are within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### *ARTICLE X - Application of Earnings and Revenues*

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, offices, directors, or other private persons, except that

the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IX hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 501(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


#### *ARTICLE XI - Distribution of Assets*

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

#### *ARTICLE XII - Amendment to Articles*

These articles of incorporation may only be amended by a majority of the directors at a meeting and in such manner as provided in the bylaws of the corporation, or in the event the bylaws are silent on any issue, as established by the laws of the State of Florida.

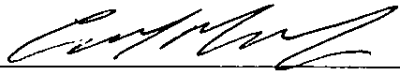

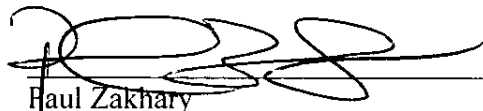
