This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to financially support the Fitness Ministers Certification Process and the Ministry thereof. This Fitness Ministers Certification is a ministry certification program which educates and then certifies accredited Fitness trainers free of charge! Teaching these accredited trainers to operate from their Christ mentality in Love ultimately ministering to the Body of Christ All Things as it relates to the stewardship of the Temple of God Our Bodies! FMA Inc. will also aid the Fitness Ministry in raising operating capital via membership dues, tithes, and the use of various fundraising activities. FMA Inc. was also formed to provide varied support and resources to equip the Fitness Minister in working with the "body of Christ" to better understand biblical principles and how they relate to physical fitness and overall health. This will be done by offering leadership, continuing education, an online community, etc., while also helping to build and nurture relationships within the body of Fitness Ministers, encouraging them to keep strong in the Word of God. FMA Inc. will operate via business to business strategic alliances and relationships. Because of the unique positioning of the FMA Inc.s Directors in the Health, Fitness and Nutrition Industry, no doubt Prepared by Christ, FMA Inc. will bridge the gap between Fitness Ministers and the overall Health, Fitness and Nutrition industries. FMA Inc. will offer businesses, organizations and Ministries solutions to their health, fitness and nutrition related needs and concerns which may include: Job bank, speakers bureau, seminars, the sale and distribution of educational health related materials & books, advertising opportunities around various media ops, nutrition company and/or product endorsements, specialized fitness/gym consulting, fitness and/or nutrition presentations, etc.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.
