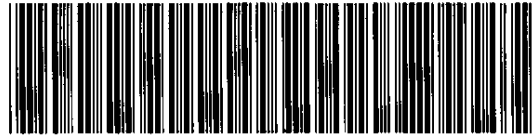



### ARTICLE VIII

SECRETARY OF STATE

This corporation, Johnson Hill-Washington Heights Community Outreach Incorporated, is organized exclusively for religious, charitable, scientific, literacy, or educational purposes within the meaning of section 501 (C) 3 of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) 3 of the Internal Revenue Code or the corresponding section of any future United States Internal Revenue law.
