**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for profit) 2009 MAY 19 AM 8:20

**MULTI-DIMENSIONAL SERVICES & SUPPORTS, INC.**

A Nonprofit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

**ARTICLE I – NAME**

The name of this corporation shall be:

**MULTI-DIMENSIONAL SERVICES & SUPPORTS, INC.**

**ARTICLE II – PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be at 2835 Lorimier Terrace in Jacksonville, Florida 32207.

**ARTICLE III – PURPOSE**

The specific purposes for which this corporation is organized are: To provide charitable and educational assistance to the general public aimed primarily towards at-risk, vulnerable children and adults by organizing and providing short and long term supportive services that increase and broaden their education, experience and exposure in community settings.

This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code.

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized as permitted under the laws of the State of Florida and in all other states and counties, provided, however, that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(c)(3) tax-exempt purposes, which are described in other provisions of these articles.

## **ARTICLE IV – MANNER OF ELECTION**

The manner in which the directors are elected or appointed: The method of election of directors is as stated in the bylaws of this corporation.

## **ARTICLE V – INITIAL DIRECTORS AND/OR OFFICERS**

The number of initial directors of this corporation shall be three and the names, addresses and titles are as follows:

## **ARTICLE VIII – TERM OF EXISTENCE**

This corporation is to exist perpetually.

## **ARTICLE IX – ADDITIONAL PROVISIONS**

The classes, rights, privileges, qualifications, and obligations of directors, officers, and members of this corporation are as stated in the bylaws of this corporation.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

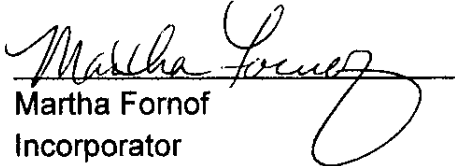
The property of this corporation is irrevocably dedicated to charitable and educational purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

## **ARTICLE X – AMENDMENTS**

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be proposed by a member of the Board of Directors and approved at a Board of Directors meeting by a majority vote, unless a signed written statement manifesting their intention is alternately provided in their absence from a Board of Directors meeting.

## ARTICLE XI – EFFECTIVE DATE

These Articles of Incorporation shall be effective on the date of filing.

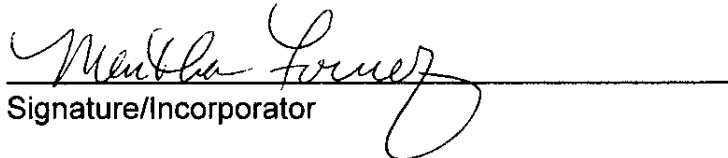
