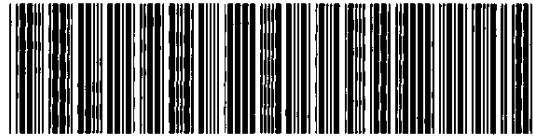

**Article V – Organization Structure:**

1. The organization structure shall be formed as an Ecclesiastical Corporation Sole for religious and charitable purposes under the Ecclesiastical Canon Law as protected by Article 1, Section 10 of the Constitution of the United States, which is endowed solely by private benefactions, in a private eleemosynary corporation.

2. As a Non-Profit Church Organization with an established place of worship that meets the requirements of IRC section 501©(3), IRC section 508©1A, Publication 557, and Publication 1828; We are “automatically tax-exempt” and/or are not required to apply for and/or obtain recognition of tax-exempt status from the IRS under the 501©3.

3. As a Non-Profit Church Organization, by law, all contributions and donations given to/ received by “LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER” are/is tax-deductible.

4. The existence of “LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER” shall be perpetual.

**Article VI - Purpose:**

1. The purpose of this church organization shall be to establish, oversee, and maintain youth programs and outings, spiritual edification of the body by spreading the Gospel of Jesus Christ, conduct the work of evangelism worldwide, create departments necessary to support missionary activities and to restore the true identity of God's children according to the Holy Bible, and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, exclusively for charitable, religious and educational purpose.
2. To assemble for worship and prayer in unity in our Lord Jesus Christ according to the Holy Bible.
3. To acquire and possess, by donation, gift, bequest, devise or purchase, and to hold and maintain property, real, personal and mixed, and to grant, sell, convey, rent or otherwise dispose of the same as may be necessary to carry on or promote the objects of the corporation.
4. All deeds and other instruments in writing must be made in the name of the corporation and signed by the person representing the CHURCH OF JESUS CHRIST ENTITLED, "LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER"

**Article VII – Property/ Powers:**

1. The Successor in the Office of Presiding Head Pastor/ Overseer of Yeshuwa' International Assembly Deliverance Ministries shall be appointed as the Overseer of "LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER" at all times.
2. The property and powers of the church, a Corporation Sole establishment shall be under the authority of the CHURCH OF JESUS CHRIST ENTITLED, "LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER" and shall be transferred on the death/ resignation of an incumbent to his/ her successors in the office of Presiding Head Overseer to oversee on behalf of this church organization.
3. In the event of the death or resignation of the OFFICE of Presiding Overseer when the person is at the time a corporation sole, his/her successor in office, as such corporation sole, is vested with the title to all property held by his/her predecessor, as such corporation sole, with lie power and authority over the property to oversee on behalf of the CHURCH OF JESUS CHRIST ENTITLED, "LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER"
4. The successor shall record in the office of the county recorder of each county wherein any of the real property is situated a certified copy of his/her commission, certificate or letter of appointment.

**Article VIII – Manner of Election/ Membership:**

1. The manner of Election shall be as set forth in and regulated by the Bylaws of this church organization.
2. Anyone shall qualify as a member of the CHURCH OF JESUS CHRIST ENTITLED, “LAST FRONTIER WARRIORS OF REDEMPTION YOUTH CENTER” and will be admitted when he/ she is accepted by membership guidelines as set forth in and regulated by the Bylaws of this church organization without prejudice of race or handicap.
3. The purpose of all members should be Salvation, Baptism, Sanctification, Education in the Holy Bible, and Filled with the Holy Spirit in the Name of the Lord Jesus Christ.


