Articles of Incorporation of a Nonprofit Corporation for the State of Florida

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

The name of the corporation shall be:

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purposes for which this community center is organized are exclusively religious, charitable, scientific, literary and/or educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. We will provide community education classes to include tutoring, performance arts activities, health, nutrition and fitness workshops and family mentoring.

ARTICLE IV: MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Directors shall be elected, annually, by the Board of Directors by a majority vote. A nomination committee may be formed to nominate new directors, officers or members, as need. Each director shall hold office until a successor is elected and qualified. A director may be elected to succeed himself or herself as director. The initial year of operations, the president and /or founder will appoint the first board of directors and shall set their terms.




