- or corresponding section of any future Federal tax code, or shall be distributed to the federal government . Or shall be distributed to the Federal Government , or to a State or local Government , for a public charitable purpose.

Any such assetts not disposed of shall be disposed of by the court of common pleas, of the county in which the principal office of the organization is then located, exclusively for such purposes or to organizations as said court shall determine, wich are organized and operated exclusively for such purposes.

2. All rescued livestock, pets, and other animals, shall remain forever in their foster homes or adopted homes. Disolution of this corporation shall not displace these animals further. Upon disolution of this corporation ownership of the animals in its care, shall remain with the person or persons, with which the animals reside, as one of the goals of this Corporation is to provide a safe, permanent, lifetime home to unwanted, formerly abused, deformed, crippled and hard to place animals. From that time forward these animals will be the sole responsibitly of the caretaker who accepts full ownership at such time this corporation should... for whatever reason, disolve.
