Article III- Passion for Paws specific purpose for which this corporation is organized

is to reduce cat and dog euthanizations in Palm Beach County, Florida.

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to orgs. that qualify as exempt orgs. under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

Upon dissolution of the org., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal govt, or to a state and local govt for a public purpose. Any such assets or disposed of shall be disposed of by the Court of Commons Pleas of the County in which the principal office of the org. is then located, exclusively for such purposes or to such org. or orgs as said Court shall determine, which are organized and operated exclusively for such purposes.
